**PA Convention Center Board Re-elects Gregory J. Fox as Chairman**

*John McNichol re-elected Vice Chairman of the Board*

PHILADELPHIA, PA -The Board of Directors of the Pennsylvania Convention Center Authority yesterday re-elected Gregory J. Fox, Esquire as Chairman of the Board of Directors and John J. McNichol of Greenlee Partners as its Vice Chairman.

Gregory J. Fox is a partner with Montgomery McCracken in Philadelphia. He has served as chairman of the 15-member board of the Pennsylvania Convention Center Authority since his initial election in May 2011. Fox is a resident of Abington Township, Montgomery County, Pa.

Fox is chair of Montgomery McCracken's Business Department and a member of the firm's management committee. He has extensive experience at the national and international level with respect to the implementation and ongoing operation of qualified retirement plans; non-qualified deferred compensation arrangements, executive incentive plans, severance agreements, and welfare benefit plans. McNichol's background includes public service as legislative aide to a former Member of Congress. He spent eight years in Washington, D.C. and, while there, McNichol established and ran the largest legislative service organization in Congress: the Congressional Fire Services Caucus and Institute.

He joined Greenlee and Keystone Strategies in 2000 after six years as a senior vice president and director of government affairs services for Tierney Communications in Philadelphia and Washington, DC. McNichol is a resident of Glen Mills, Delaware County, Pa.
